Application to participate in future Terra Verde Offset Contract

**APPLICATION FOR INCLUSION OF POTENTIAL SOIL CARBON OFFSET CREDITS
(the “Credits”) and AGREEMENT FOR INCLUSION OF CREDITS**

1. The undersigned (the “Producer”) requests that Terra Verde Emissions Credits Inc. (“Terra Verde”) act as agent for the Producer to market Credits that may at any time during the term of this agreement become available to and arise from the lands (the “Lands”) described in the Information Sheet attached hereto and forming part hereof.
2. The Producer acknowledges that the opportunity for generation and sale of Credits in respect of the Lands have not been announced by regulatory bodies (whether federal or provincial) as at the date hereof. By executing this agreement, the Producer agrees that Terra Verde shall be the Producer’s sole and irrevocable agent for the purposes of aggregating and marketing any Credits that may be generated from the Lands. The appointment of Terra Verde as agent for the Producer shall be in respect of all Credits and opportunities for Credits arising during the period up to and including December 31, 2010 (including, without limiting the generality of the foregoing, any Credits arising at any time prior to the date hereof). In the event that the Province in which the Producer’s Lands are located does not pass legislation on or before December 31, 2010, creating Offset Credits for the Producer or Terra Verde to sell, then this agreement shall be null and void.
3. The Producer and Terra Verde agree that the Terms and Conditions applicable to the Credits to which this agreement applies shall be the Terra Verde Terms and Conditions for its Series V Contract as published on the Terra Verde website (www.terraemissions.com) and otherwise made available to the Producer and the Producer acknowledges having reviewed such Terms and Conditions. All terms, conditions, representations and warranties as therein contained are incorporated in and are applicable to this agreement. The Producer will at all times comply with requirements and conditions applicable to the market on which the Credits are or are to be sold and traded.
4. The Producer shall provide Terra Verde with any additional information respecting the Lands, the tillage equipment and practises and any other information and data that Terra Verde requests in writing. The Producer shall supply such additional information for 2010 and prior years no later than July 31, 2010.
5. Upon acceptance of this application by Terra Verde, there is a binding agreement between Terra Verde and the Producer on the terms stated herein. Terra Verde shall calculate the possible Credits on the Lands for the applicable years, and shall advise the Producer in writing. Terra Verde shall use reasonable efforts to market the Producer’s Credits as it is able to do so. In the event that the Producer wishes to include more land in this agreement, the Producer may apply to include such additional land in the contract with Terra Verde. If accepted by Terra Verde, the terms relating to the Credits on such additional land shall be on such terms as are then available for Credits. Unless otherwise agreed, Terra Verde shall be paid a commission of 15% of the Gross Selling Price for the Credits, to be deducted with GST thereon from the sales proceeds with such other expenses set out in the Terms. Terra Verde shall pay the Producer within 60 days of the sale of the Credits and receipt of payment in releasable form from the purchaser(s). The Credits may be pooled and sold at different times and on different terms. Partial payments may be made to the Producer if portions of the Credits are sold at different times.
6. The Producer certifies and represents that it has not disposed of or sold the Credits that would be applicable under this agreement to any other party, nor entered into any other agreement by which the Producer is obligated to sell the said Credits.
